ANNABELLE P. YUMANG, MCH, CESO III; AND THE DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER, REPRESENTED BY ITS CHIEF OF HOSPITAL, DR. REDEN V. **WHEREAS**, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the provincial
