A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 07-17-2022 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 07-17-2022 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 07, involving an appropriation of Four Million Four Hundred Thirty-Two Thousand One Hundred Eighty Four Pesos & 54/100 (P4,432,184.54), was submitted to this Sanggunian for review on January 10, 2023, pursuant to the provisions of Republic Act No. 7160:

RESOLVED, to declare Appropriation Ordinance No. 07-17-2022 of the Municipality of San Isidro, Davao Oriental, OPERATIVE IN ITS ENTIRETY as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that Re-appropriation in the amount of P3,412,396.16 under the CY 2022 20% Development Fund shall be in accordance with the approved CY 2022 Supplemental Annual Investment Program (SAIP) Development Plan, pursuant to Section 287 and 305(i) of R.A. 7160; DILG Memorandum Circular (MC) No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF-JMC No. 1, series of 2016, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. It is understood that the projects in the Supplemental AIP are likewise deliberated and favorably endorsed by the Municipal Development Council to the Sangguniang Bayan for their approval in a Resolution Form.

RESOLVED FURTHER, to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.
