A RESOLUTION FORWARDING THE APPROPRIATION ORDINANCE NO. 02-17-2023 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 02-17-2023 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of <a href="Eight Hundred Forty-Three Thousand Seven Hundred Eighty-Four Pesos & 60/100">Eight Hundred Forty-Three Thousand Seven Hundred Eighty-Four Pesos & 60/100</a> (P843,784.60). The same was submitted to this Sanggunian for review on May 16, 2023, and was docketed as Communication No. 17-418-2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides among others that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within 90 days from receipt of copies of such ordinance;
