A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR CORAZON N. MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO AND EXECUTE A DEED OF ABSOLUTE SALE (DOAS) RELATIVE TO THE PURCHASE OF A PARCEL OF LAND CONTAINING AN AREA OF 388,778 SQUARE METERS SITUATED AT BARANGAY MAPUTI, BANAYBANAY, THIS PROVINCE, FOR THE ESTABLISHMENT OF A SOLAR POWER STATION.

WHEREAS, the Honorable Governor Corazon N. Malanyaon, in her letter, dated May 31, 2023 is requesting this August Body for the passage of a resolution authorizing her relative to the aforementioned subject matter, docketed as Communication No. 17-448-2023;

behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance”;

WHEREAS, a 388,778 square meter lot is subject to sell, which is a portion of a parcel of land covered by TCT No. CLOA No. 2261, containing an area of SEVEN HUNDRED THIRTY -THREE THOUSAND SIX HUNDRED TWENTY-EIGHT (733,628) SQUARE METERS, more or less, situated at Barangay Maputi, Municipality of Banaybanay, Davao Oriental, with declared owners under the name of SYLVIA F. GONO. ET AL.;




