1. The LGU is reminded that position in the official plantilla for career position, if occupied by incumbent holding permanent appointments, must be covered with adequate appropriations (Section 325 [e]. RA 7160);
2. No Program/Project/Activity (P/P/A) should be funded in the Annual and/or Supplemental Budgets if it is not included and/or in accordance with the Approved Annual and/or Supplemental Investment Program (Sec.305(i) of RA 7160);

RESOLVED FURTHER, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.




