

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 01-2023 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 01-2023 of the Municipality of Lupon, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of <u>Eighteen Million Three Hundred Fifty-Six Thousand Seven Hundred Fifty-One Pesos (P18,356,751.00)</u>, was submitted to this Sanggunian for review on March 30, 2023, pursuant to the provisions of Republic Act No. 7160;

**RESOLVED,** to declare Appropriation Ordinance No. 01-2023, of the Municipality of Lupon, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. The LGU is reminded that position in the official plantilla for career position, if occupied by incumbent holding permanent appointments, must be covered with adequate appropriations (Section 325 [e]. RA 7160);
- No Program/Project/Activity (P/P/A) should be funded in the Annual and/or Supplemental Budgets if it is not included and/or in accordance with the Approved Annual and/or Supplemental Investment Program (Sec.305(i) of RA 7160);

**RESOLVED FURTHER,** to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.
