

MOREOVER, we would like to remind you of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016, which requires that within three (3) days after approval of the Ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Sangguniang Panlalawigan for review.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental, through the Municipal Mayor.
