A RESOLUTION FORWARDING APPROPRIATION ORDINANCE NO. 02, SERIES OF 2023, OF THE CITY OF MATI, DAVAO ORIENTAL, TO THE PROVINCIAL LOCAL FINANCE COMMITTEE, THROUGH THE PROVINCIAL BUDGET OFFICER, THIS PROVINCE, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF, PURSUANT TO SECTION 316(f) OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Appropriation Ordinance No. 02, series of 2023, of the City of Mati, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 02. involving an appropriation of P14,838,619.06. The same was submitted to this Sanggunian for review on June 1, 2023, and was docketed as Communication No. 17-442-2023;
