Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, thru his letter, dated May 30, 2023, docketed as Communication No. 17-441-2023, submitted copies of City Ordinances, including City Ordinance No. 564, series of 2023, for review of the 17th Sangguniang Panlalawigan of this Province;

WHEREAS, the said Ordinance was enacted by the 7th Sangguniang Panlungsod of the City of Mati on its 19th Regular Session held last May 9, 2023, in adherence to the mandate for the local government to be responsive to the situation and initiate programs that specifically address the negative ramification caused by the COVID-19 pandemic;


