A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 565, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING BY INSERTION/ADDITION OF PROVISIONS UNDER CITY ORDINANCE NO. 528, SERIES OF 2023 BY PROVIDING ADDITIONAL FRANCHISE FOR THE CITY PROPER ROUTE”, PURSUANT TO ARTICLE III, SECTION 458(a)(3)(vi) OF REPUBLIC ACT 7160.

WHEREAS, the Sangguniang Panlungsod, is mandated to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city, subject to the guidelines prescribed by the Department of Transportation and Communications, pursuant to Article III, Section 458(a)(3)(vi) of Republic Act 7160;

WHEREAS, Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, submitted various city ordinances, including City Ordinance No.

565, series of 2023, on the 30th day of May 2023 for review of the August Body, docketed as Communication No. 17-441-2023;

WHEREAS, the said ordinance was enacted by the 7th Sangguniang Panlungsod of Mati, this province, to provide additional One Hundred (100) units of franchise for the City Proper Route to cater the 3rd batch qualified Tricycab (Bao-bao) operators at a ratio of one franchise per one operator respectively;

WHEREFORE, on motion of SP Member Daud V. Linsag, duly and jointly seconded by SP Members Harold A. Montes, Rotchie M. Ravelo, Stephen Paul L. Uy, Eleuterio C. Manaytay, and Art Benjie C. Bulaong, it was
