A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 15-07-06-2023 OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE REVISING THE CHILDREN’S WELFARE CODE OF THE MUNICIPALITY OF BOSTON, PROVINCE OF DAVAO ORIENTAL, AND FOR OTHER PURPOSES”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, the Sangguniang Bayan of Boston, Davao Oriental, submitted Municipal Ordinance No. 15-07-06-2023 to the Sangguniang Panlalawigan for an appropriate legislative action;

WHEREAS, the said Municipal Ordinance was enacted to adhere to the international, national and local laws to promote the rights of children to survival, development, protection and participation and effectively institutionalize the comprehensive framework, integrative, sustainable and equitable development;

WHEREAS, the municipality commits to defend the right of children to assistance, including health, nutrition, education, and special protection from all forms of abuses, neglect, cruelty, exploitation and discrimination, and other conditions prejudicial to their interests and provide sanctions for their commission;

WHEREFORE, on motion of SP Member Stephen Paul L. Uy, duly and jointly seconded by SP Members Daud V. Linsag, Rotchie M. Ravelo, Harold A. Montes, Andy A. Monday, and Ronald T. Lara, Jr., it was




