A RESOLUTION AMENDING SP RESOLUTION NO. 17-412-04-2023 BY SPECIFYING THE CONCERNED OFFICES, AND THE SAME AS AMENDED, SHALL NOW READ AS FOLLOWS: "A RESOLUTION FORWARDING TO THE CIVIL SERVICE COMMISSION, DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, DEPARTMENT OF FINANCE AND BUREAU OF LOCAL GOVERNMENT FINANCE, THE VERIFIED COMPLAINT OF MR. SERGS P. IGNACIO AGAINST MUNICIPAL TREASURER, NORMA B. MORALES, AND FORMER MUNICIPAL MAYOR ARTURO C. MONDAY, ALL OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, THE SAME BEING FILED BEFORE THE OFFICE OF THE OMBUDSMAN-MINDANAO, FOR THEIR INFORMATION, SCRUTINY AND APPROPRIATE ACTION."

WHEREAS, SP Resolution No. 17-412-04-2023, entitled: "A resolution forwarding to the concerned offices the verified complaint of Mr. Sergs P. Ignacio against Municipal Treasurer, Norma B. Morales, and former Municipal Mayor Arturo C.

Monday, all of the Municipality of Baganga, Davao Oriental, the same being filed before the Office of the Ombudsman – Mindanao, for their information, scrutiny and appropriate action", was enacted by this august body last April 12, 2023 on its 41<sup>st</sup> regular session;

WHEREAS, filed before the Office of the Ombudsman–Mindanao by Mr. Sergs P. Ignacio against Municipal Treasurer Norma B. Morales and former Municipal Mayor Arturo C. Monday, all of the Municipality of Baganga, Davao Oriental, is the following cases with References:

- ➤ <u>IC-OM-20-0533</u>—Robbery incident at the Office of the Municipal Treasurer, Baganga, Davao Oriental, on November 10, 2014;
- ➤ IC-OM-22-0319 Serious, Malicious Grave Threats

WHEREAS, these complaints are not under the jurisdiction of the Sangguniang Panlalawigan pursuant to Section 61 of R.A. 7160, considering that the respondents are **not local elective officials** of the Municipality, since Norma Morales is a Municipal Treasurer, and Arturo C. Monday is a former Mayor whose term ended on June 30, 2022;

WHEREAS, consistent with encouraging good governance through transparency, accountability, integrity, the absence of corruption, and wrongdoings, among other things. This Committee believes that these agencies/offices can take necessary actions on matters/complaints of irregularities committed in the agency, in this case, the Municipal Government of Baganga, if the acts committed are proven to be in grave violation of and/or against the laws relative thereto;

**WHEREFORE**, on motion of SP Member Joselito B. Villademosa, duly and jointly seconded by SP Members Stephen Paul L. Uy, Harold A. Montes, Shella Marie S. Go, Anna Cheryl N. Castro, and Marietta D. Palmera, it was
