A RESOLUTION FORWARDING VARIOUS APPROPRIATION ORDINANCES OF DIFFERENT LOCAL GOVERNMENT UNITS OF THIS PROVINCE, TO THE PROVINCIAL BUDGET OFFICER, THIS PROVINCE, FOR TECHNICAL REVIEW AND APPROPRIATE RECOMMENDATION THEREOF.

WHEREAS, Appropriation Ordinance No. 02-22-05-2023 of the Municipality of Cateel, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of P1,429,883.29. The same was submitted to this Sanggunian for review on June 7, 2023, and was docketed as Communication No. 17-458-2023;

WHEREAS, Appropriation Ordinance No. 2023-20-01 of the Municipality of Manay, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of P34,150,585.76. The same was submitted to this Sanggunian for review on June 22, 2023, and was docketed as Communication No. 17-487-2023;

WHEREAS, Appropriation Ordinance No. 2023-02 of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of **P5,185,950.32.** The same was submitted to this Sanggunian for review on June 26, 2023, and was docketed as Communication No. 17-484-2023;

WHEREAS, Appropriation Ordinance No. 94, series of 2023, of the Municipality of Boston, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of **P16,851,893.63**. The same was submitted to this Sanggunian for review on June 27, 2023, and was docketed as Communication No. 17-485-2023;

WHEREAS, Appropriation Ordinance No. 01-17-2023 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of **P12,787,907.72.** The same was submitted to this Sanggunian for review on July 3, 2023, and was docketed as Communication No. 17-488-2023, and there is no Supplemental Annual Investment Program (SAIP) attached;

WHEREAS, Appropriation Ordinance No. 02, series of 2023, of the Municipality of Governor Generoso, Davao Oriental authorizing its CY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of <u>P13,937,213.00</u>. The same was submitted to this Sanggunian for review on July 7, 2023, and was docketed as Communication No. 17-500-2023;

WHEREAS, Section 327 of the Local Government Code of 1991 provides that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities within the province, within 90 days from receipt of copies of such ordinance;

WHEREAS, the Sangguniang Panlalawigan finds the assistance of the Provincial Budget Office necessary in the review, evaluation together with its recommendation relative to the budgets of component cities and municipalities thereof;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Stephen Paul L. Uy, Shella Marie S. Go, Andy A. Monday, and Harold A. Montes, it was
