A RESOLUTION ENDORSING TO THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., THROUGH THE PROVINCIAL AGRICULTURIST, THE HEREIN LETTERS FROM THEN GOVERNOR CORAZON N. MALANYAON, RELATIVE TO THE REQUEST FOR LEGISLATIVE MEASURES BY THIS SANGGUNIANG PANLALAWIGAN, FOR WHATEVER ACTION DEEMED APPROPRIATE THEREOF.

WHEREAS, Communication No. 17-459-2923 pertains to the letter from then Governor Corazon N. Malanyaon, dated June 1, 2023, which was received by the Sangguniang Panlalawigan Support Services Office on June 8, 2023 and was referred to the Committee on Agriculture & Food on June 14, 2023, requesting for the passage of Provincial Ordinances, viz:

a) AN ORDINANCE ESTABLISHING THE STIMULUS FUND FOR AGRICULTURAL BUSINESS DEVELOPMENT PROGRAM FOR LOCAL FARMERS, FISHERFOLKS, AND THE YOUTH IN AGRICULTURE OF THE PROVINCE QF DAVAO ORIENTAL, APPROPRIATING FUNDS

- THEREFOR, AND PROVIDING GUIDELINES FOR ITS IMPLEMENTATION.
- b) AN ORDINANCE INSTITUTIONALIZING THE AGRISTUDYANTE SCHOLARSHIP PROGRAM FOR LOCAL YOUTH IN AGRICULTURE OF THE PROVINCE OF DAVAO ORIENTAL, APPROPRIATING FUNDS THEREFOR, AND PROVIDING GUIDELINES FOR ITS IMPLEMENTATION.
- c) AN ORDINANCE PURSUING THE SUSTAINABLE IMPROVED PAGKAIN AT KITA PROGRAM TO INTENSIFY FOOD SUFFICIENCY AND REGULAR INCOME OF SMALL FARMING AND FISHING HOUSEHOLDS IN DAVAO ORIENTAL, APPROPRIATING FUNDS THEREFOR, AND PROVIDING THE MECHANISM FOR ITS IMPLEMENTATION AND OTHER PURPOSES.

WHEREAS, Communication No. 17-483-2023 pertains to the letter from then Governor Corazon N. Malanyaon, dated May 22, 2023, which was received by the Sangguniang Panlalawigan Support Services Office on June 26, 2023 and was referred to the Committee on Agriculture & Food on July 5, 2023, for the passage of a resolution requesting assistance from the Department of Agriculture Regional Field Office XI thru the National Urban and Peri-Urban Agriculture Program (NUPAP) relative to the establishment of Grow-Out Nursery in the province;

**WHEREAS**, in light of the new administration, this august body believes that the aforementioned requests need to be endorsed to the present Local Chief Executive for his perusal and whatever action deemed appropriate thereof;
