**A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 06, SERIES OF 2023, OF THE SANGGUNIANG BAYAN OF TARRAGONA, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE PRESCRIBING GUIDELINES FOR THE IMPLEMENTATION OF MEAT INSPECTION SERVICE IN THE MUNICIPALITY OF TARRAGONA”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO SECTION 447(a) OF THE LOCAL CODE OF 1991 OR RA 7160.**




