**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-01 SERIES OF 2023, OF THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 2023-01 of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of **Twelve Million Three Hundred Thousand Pesos (P12,300,000.00)**, was submitted to this Sanggunian for review on April 18, 2023, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2023-01 of the Municipality of Banaybanay, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to conditions:

Fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2023 Supplemental Annual Investment Program (SAIP)/Development Plan pursuant to Sections 287 and 305(i) of R.A. 7160; DILG Memo Cir. (MC) No. 2004-130, dated October 1, 2004; DILG NEDA-DBM-DOF JMC No. 1, series of 2016, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. It is understood that the PPAs in the Supplemental AIP in this budget were likewise deliberated and favorably endorsed by the Municipal Development Council to the Sangguniang Bayan for their approval in a resolution form, a copy of the aforesaid resolution shall be attached as supporting documents of this budget.

**RESOLVED FURTHER**, to inform the Municipality of Banaybanay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Banaybanay, Davao Oriental, through the Municipal Mayor.




