WHEREAS, Appropriation Ordinance No. 02-2023 of the Municipality of Lupon, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of P1,109,536.80. The same was submitted to this Sanggunian for review on July 12, 2023, docketed as Communication No. 17-504-2023;

WHEREAS, Section 327 of the Local Government Code of 1991, provides that the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities within the province, within 90 days from receipt of copies of such ordinance;

WHEREAS, the reglementary period of review of the said budget document will end on October 10, 2023;
