WHEREAS, the Province of Davao Oriental has already created the Special Health Fund with the Development Bank of the Philippines-Mati Branch last June 6, 2023 with corresponding book of accounts. The creation of the Special Health Fund (SHF) which shall be used by the province-wide health system to pool and manage all resources intended for health services, is provided in Section 20, of the IRR of RA 11223;

WHEREAS, Department of Health Administrative Order No. 2020-0037 on the Guidelines on Implementation of the Local Health Systems Maturity Levels, as supported by the DOH-DBM-DOF-DILG-PhilHealth Joint Memorandum Circular No. 2021-0001 requires that component LGUs of all UHC implementing sites create and maintain a subsidiary ledger in their trust fund for funds that will be transferred to them from the Special Health Fund;




