A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DY GREEN ENERGY CORPORATION, REPRESENTED BY ITS OPERATION MANAGER, MR. DONNY T. YEUNG, RELATIVE TO THE DEVELOPMENT OF A SOLAR PHOTOVOLTAIC POWER GENERATION FACILITY EMBEDDED IN THE DISTRIBUTION SYSTEM OF DAVAO ORIENTAL ELECTRIC COOPERATIVE (DORECO), IN BARANGAY MAPUTI, BANAYBANAY, THIS PROVINCE.

WHEREAS, the Honorable Governor Niño Sotero L. Uy, Jr., has submitted before the august body, an urgent request for the passage of a resolution authorizing him to enter into a Memorandum of Agreement (MOA), for and in behalf of the Province of Davao Oriental, with the DY Green Energy Corporation, a duly registered power generation company, offering to develop a solar photovoltaic power generation facility embedded in the distribution system of Davao Oriental Electric Cooperative (DORECO);

WHEREAS, the DY Green Energy Corporation approached the Provincial Local Government Unit of Davao Oriental to supply renewable and environmentally responsible power supply to DORECO from the said solar photovoltaic power generation facility through a Power Supply Agreement;

WHEREAS, the said corporation, among other things, shall have the exclusive property use for 15 years of the 40 hectare-property situated in Barangay Maputi, Municipality of Banaybanay, owned by the PLGU, which is to be leased by the Corporation at the amount of P500,000.00 per month, subject to the terms and conditions of a lease agreement;

WHEREAS, the said corporation, among other things, shall build and operate Solar PV Project which shall supply at least 50 MV to the PLGU, during the effectivity of the Agreement;

WHEREFORE, on motion of SP Member Joselito B. Villademosa, duly and jointly seconded by SP Members Harold A. Montes and Stephen Paul L. Uy, it was
