A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 15-06-06-2023 OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 07, SERIES OF 2014, ENTITLED: “AN ORDINANCE IMPOSING CURFEW TO PERSONS BELOW EIGHTEEN (18) YEARS OF AGE AND PROVIDING INTERVENTION PROGRAM FOR ITS VIOLATION”, BY DELETION AND ADDITION OF SOME PROVISIONS THEREOF”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.
