A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 94. SERIES OF 2023, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY.

**RESOLVED, FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.
