RESOLVED FURTHER, to inform the Municipality of Boston, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED, FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.




