Rabat, on the 27th day of June 2023, in compliance to the Philippine Statistics Authority (PSA) Board Resolution No. 4, Series of 2023, enjoining the Provincial, City, and Municipal governments to issue an order for the creation of Provincial, City and Municipal Census Coordinating Boards (CCBs) to ensure the cooperation of all government units and private entities; and to streamline the census operations at the local level during the conduct of the 2022 Census of Agriculture and Fisheries with the objective of providing government planners and policy makers with data on which to base their plans for the country's development;




