AN ORDINANCE REVERTING TO THE UNAPPROPRIATED BALANCES OF THE CY 2023 GENERAL FUND THE APPROPRIATIONS FOR SAVINGS FROM SALARIES AND OTHER COMPENSATIONS OF VARIOUS OFFICES, CAPITAL OUTLAY OF VARIOUS OFFICES, 20% LOCAL GOVERNMENT DEVELOPMENT FUNDS (LGDF) – CY 2020, 2021, & 2022 CONTINUING APPROPRIATIONS, AND CY 2023 CURRENT APPROPRIATIONS, AND LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND CY 2023 CURRENT APPROPRIATIONS; AND FURTHER AUTHORIZING ITS CORRESPONDING APPROPRIATIONS TO FUND VARIOUS PRIORITY PROGRAMS /PROJECTS/ACTIVITIES OF THIS PROVINCE.

Be it ordained by the 17th Sangguniang Panlalawigan of Davao Oriental, in session duly assembled that:

SECTION 1. REVERSION - It is hereby approved the reversions to the CY 2023 Unappropriated balances of the General Fund Annual Budget of the Provincial Government of Davao Oriental the appropriations for the savings from salaries and other compensations of various offices, Capital Outlays of various offices, 20% LGDF – CY 2021, 2020, 2022 Continuing Appropriations and CY 2023 Current Appropriations, and LDRRMF – CY 2023 Current Appropriations, in the amount of **₱99,785,350.77**, to wit:

- Actual salary savings of various offices/departments in the amount of **₱28,696,888.95**
- Salaries and other compensations under the Vice Governor's Office and SP-Support Services Office in the amount of **₱ 773,530.07**
- Capital Outlays of PHO-Public Health, LCPC and Senior Citizen program in the amount of **₱ 5,450,000.00**
- 20% LGDF – 2020 Continuing Appropriation in the amount of **₱ 550,140.00**
- 20% LGDF – 2021 Continuing Appropriation in the amount of **₱ 7,250,618.78**
- 20% LGDF – 2022 Continuing Appropriation in the amount of **₱19,226,025.39**
- 20% LGDF – 2023 Current Appropriation in the amount of . . . **₱19,230,147.58**
- LDRRMF – 2023 Current Appropriation in the amount of **₱18,608,000.00**

SECTION 2. EFFECTIVITY- This Ordinance shall take effect immediately upon approval.


