A RESOLUTION AMENDING SP RESOLUTION NO. 17-03-07-2023, ENTITLED: “A RESOLUTION ADOPTING THE STANDING COMMITTEES OF THE 17TH SANGGUNIANG PANLALAWIGAN OF DAVAO ORIENTAL AND ITS COMPOSITION”, BY REORGANIZING THE COMPOSITION OF THE STANDING COMMITTEES.

WHEREAS, the 17th Sangguniang Panlalawigan of this province enacted Resolution No. 17-03-07-2022 on the 13th day of July, 2022;

WHEREAS, Rule VII, Section (3)(b) of the Internal Rules of Procedures of the 17th Sangguniang Panlalawigan of this province provides that: “ *The Presiding Officer or any Sanggunian Member may recommend the creation/re-organization of any regular or standing committee or special or ad-hoc committee. The Sanggunian shall act on the said recommendation;*”

WHEREAS, in furtherance to the above cited provision, the Honorable Daud V. Linsag presented a motion for consideration before the August Body in the form of resolution declaring

all standing committees vacant, to re-organize the composition of 17th Sangguniang Panlalawigan Standing Committees, during the 60th Regular Session of the 17th SP held last August 23, 2023;


