UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL GOVERNMENT OF BANAYBANAY, REPRESENTED BY ITS MAYOR, HONORABLE LEMUEL IAN M. 




