A RESOLUTION CONFIRMING THE APPROVAL OF MUNICIPAL ORDINANCES NOS. 2023-04, 2023-05, AND 2023-06, ALL SERIES OF 2023, OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, CONSIDERING THAT THE SAME ARE WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, Municipal Ordinance No. 2023-04, entitled: “An Ordinance amending Municipal Ordinance No. 2021-04, institutionalizing the program, services, privileges and benefits for solo parents and their children in the Municipality of Lupon, Davao Oriental, appropriating funds therefor and for other purposes, pursuant to Republic Act (RA) No. 11861, amending RA No. 8972, otherwise known as the “Expanded Solo Parents Welfare Act”;

WHEREAS, the said municipal ordinance otherwise known as the “Expanded Solo Parents Welfare Ordinance of 2023” was enacted during the 56th regular session of the 20th Sangguniang Bayan of Lupon, on August 14, 2023;

WHEREAS, Municipal Ordinance No. 2023-05, entitled: “*Revising the Children’s Welfare Code of the Municipality of Lupon, Province of Davao Oriental, and for other purposes*” was passed and approved to revise the aforementioned code which is now otherwise known and cited as the “*Revised Children’s Welfare Code 2023*”;

WHEREAS, Municipal Ordinance No. 2023-06, entitled: “An Ordinance institutionalizing the expanded benefits of the Pantawid Pamilyang Pilipino Program (4Ps) in the Municipality of Lupon, Davao Oriental”, was passed and approved in support to the Pantawid Pamilyang Pilipino Program (4Ps) of the National Government;

WHEREAS, in her letter dated August 16, 2023, Ms. Fatima L. Malaluan, MPA, Secretary to the Sangguniang Bayan of Lupon, Davao Oriental, submitted the above municipal ordinances for legislative review of the Sangguniang Panlalawigan, docketed as Communication No. 17-562-2023;

WHEREFORE, on motion of SP Member Shella Marie S. Go, duly and jointly seconded by SP Members Daud V. Linsag and Stephen Paul L. Uy, it was




