WHEREAS, the Honorable Art Benjie C. Bulaong delivered a privilege speech before the August Body during the 59th Regular Session, dated August 16, 2023;

WHEREAS, in his speech, the Honorable Bulaong shed light regarding the development loan with the said banks. There are details of information that needs to be addressed to ensure the best interest of the people of Davao Oriental;

WHEREAS, the Honorable Bulaong proposed to refer the said matter to the Oversight Committee and for the Sangguniang Panlalawigan to intervene as it is also the duty of the SP Members as representatives of the people of Davao Oriental;

WHEREAS, the said proposal was put into motion by the Honorable Art Benjie C. Bulaong, seconded by Honorable Board Members Harold A. Montes, Daud V. Linsag, Rotchie M. Ravelo, Andy A. Monday, Eleuterio C. Manaytay, Rustan R. Castellones, and Joselito B. Villademoso and was subsequently referred to the Oversight Committee.;

WHEREAS, Provincial Ordinance No. 16-47-11-2020, entitled: "*An Ordinance enacting the Rules of Procedure on Legislative Inquiry in Aid of Legislation of the Sangguniang Panlalawigan of Davao Oriental*", defines the powers of the Sangguniang Panlalawigan en banc or through its committee to conduct legislative inquiry in aid of legislation;

WHEREAS, Section 3 – Coverage, of the said Ordinance, states that: "This ordinance shall govern the *legislative inquiry in aid of legislation* that may be conducted by the Sangguniang Panlalawigan en banc or through its committees on matters which in its own initiative be inquired into, to gather relevant inputs, information, which are and testimonies material to any complaint, controversy or proposed legislative measures, or amendments to existing laws or for future legislations";

WHEREFORE, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Rotchie M. Ravelo, Stephen Paul L. Uy, Daud V. Linsag, Anna Cheryl N. Castro, Andy A. Monday, and Art Benjie C. Bulaong, it was


