A RESOLUTION RETURNING TO THE SECRETARY TO THE SANGGUNIANG, MR. MELVIN B. LUBITAÑA OF SAN ISIDRO, DAVAO ORIENTAL, HIS LETTER DATED JULY 21, 2023, WITH THE SUBJECT MUNICIPAL ORDINANCE NO. 310-17-2023, DOCKETED AS COMMUNICATION NO. 17-524-2023, FOR LACK OF CONSULTATION WITH THE PHILIPPINE HISTORICAL COMMISSION, PURSUANT TO SECTION 13(c)(3) OF RA 7160.

WHEREAS, Municipal Ordinance No. 310-17-2023 was forwarded to this august body for review, and was referred to the Committee on Disaster Preparedness on August 16, 2023 regular session;

WHEREAS, Municipal Ordinance No. 310-17-2023, entitled: “An Ordinance declaring Regional Evacuation Center as San Isidro Municipal Evacuation Center in the Municipal Evacuation Center in the Municipality of San Isidro, Davao Oriental”, is to create a sense of ownership of such structure after its donation from the Department of Public Works and Highways (DPWH);

WHEREAS, Section 13(c)(3) of RA 7160 or the Local Government Code of 1991, provides that: Section 13. *Naming of Local Government Units and Public Places, Streets and Structures*; (c) *the sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction*; (3) *City and municipal public elementary, secondary and vocational or technical schools, post-secondary and other tertiary schools*;

WHEREFORE, on motion of SP Member Art Benjie C. Bulaong, duly and jointly seconded by SP Members Rotchie M. Ravelo, Stephen Paul L. Uy, Daud V. Linsag, and Andy A. Monday, it was




