A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 09, SERIES OF 2023, OF THE SANGGUNIANG BAYAN OF TARRAGONA, DAVAO ORIENTAL, INVALID IN PART, CONSIDERING THAT SOME PROVISIONS THEREOF ARE INCONSISTENT WITH LAW, AND THAT THE SANGGUNIANG BAYAN APPROVING AND RATIFYING THE TERM LOAN AGREEMENTS TO FINANCE THE PROJECTS NOT INCLUDED IN THE APPROVED LOCAL DEVELOPMENT PLAN AND PUBLIC INVESTMENT PROGRAM OF THE MUNICIPALITY IS BEYOND THE SCOPE OF ITS PRESCRIBED POWERS, PURSUANT TO SECTIONS 296(a), 444(b)(1)(vi), AND 447(a)(2)(iii); AND RULE XXXIII, ARTICLES 394(a) AND 395(d) OF RA 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, AND ITS IMPLEMENTING RULES AND REGULATIONS, RESPECTIVELY.

After a careful and thorough deliberation, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Stephen Paul L. Uy, Daud V. Linsag, Ronald T. Lara, Jr., and Harold A. Montes, it was

RESOLVED, as it is hereby resolved, DECLARING MUNICIPAL ORDINANCE NO. 09, SERIES OF 2023, OF THE SANGGUNIANG BAYAN OF TARRAGONA, DAVAO ORIENTAL, INVALID IN PART, CONSIDERING THAT SOME PROVISIONS THEREOF ARE INCONSISTENT WITH LAW, AND THAT THE SANGGUNIANG BAYAN APPROVING AND RATIFYING THE TERM LOAN AGREEMENTS TO FINANCE THE PROJECTS NOT INCLUDED IN THE APPROVED LOCAL DEVELOPMENT PLAN AND PUBLIC INVESTMENT PROGRAM OF THE MUNICIPALITY IS BEYOND THE SCOPE OF ITS PRESCRIBED POWERS, PURSUANT TO SECTIONS 296(a), 444(b)(1)(vi), AND 447(a)(2)(iii); AND RULE XXXIII, ARTICLES 394(a) AND 395(d) OF RA 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, AND ITS IMPLEMENTING RULES AND REGULATIONS, RESPECTIVELY;
