A RESOLUTION RETURNING TO THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., THROUGH THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (PDRPMC), THE HEREIN PDRPMC RESOLUTION NO. 01, SERIES OF 2023, WITHOUT ACTION, PENDING SUBMISSION OF THE LIST OF BENEFICIARIES AS STATED THEREOF.

WHEREAS, submitted before this august body is the request of the Honorable Governor Niño Sotero L. Uy, Jr., for appropriate legislative action relative to the PDRPMC Resolution No. 01, Series of 2023, entitled: “A RESOLUTION AUTHORIZING THE REVERSION OF FUNDS WITH THE TOTAL AMOUNT OF P18,000,000.00 FROM 2023 LDRRMF - 70% PREPAREDNESS FUND UNDER CAPITAL OUTLAY (CO) ROAD NETWORKS (OPLAN KARSADA) WITH ACCOUNT CODE 1-07-03-010-05 AMOUNTING TO P5,000,000.00; OTHER STRUCTURES-CONSTRUCTION OF DISASTER RESILIENT TRANSITIONAL SHELTERS WITH ACCOUNT CODE 1-07-04-990-18 AMOUNTING TO P3,608,000.00; AND OTHER STRUCTURES (CONSTRUCTION OF STATE OF THE ART STANDARD EVACUATION CENTER

PHASE I) AMOUNTING TO P10,000,000.00 TO DONATIONS WITH ACCOUNT CODE 5-02-99-080 TO AUGMENT THE NECESSARY FUNDING REQUIRED FOR THE PAYMENT OF FOOD SUPPLIES USED DURING THE CONDUCT OF RELIEF OPERATIONS TO THE FAMILIES AFFECTED BY THE RECENT FLOODING INCIDENT ACROSS THE PROVINCE OF DAVAO ORIENTAL AND BY PROVIDING ADDITIONAL STANDBY FUNDS AS PREPAREDNESS MEASURES FOR EARLY RESPONSE FOR ANY EMERGENCIES OR CALAMITIES THAT MAY OCCUR IN THIS PROVINCE, SUCH AS BUT NOT LIMITED TO THE PROVISION OF FOOD AND NON-FOOD ITEMS, FARMING INPUTS AMONG OTHERS, AND FORWARDING THE SAME TO THE SANGGUNIANG PANLALAWIGAN FOR THEIR APPROVAL”;

WHEREAS, the said Resolution was passed and approved by the Council during its 1st Quarter Meeting on March 28, 2023;

WHEREAS, series of flooding and landslide incidents occurred in the Municipalities of Boston, Cateel, Baganga, San Isidro, Governor Generoso, and the City of Mati, on January 29, 2023 and February 14, 2023, respectively;

WHEREAS, based on the reports by MDRRMO Operation Center, there were 10,395 families affected and 1 death due to the flooding incident. Around 346 families from Barangays Tibanban, Poblacion, Don Aurelio Chicote, Tamban, and Crispin dela Cruz, all in Governor Generoso, were evacuated;

WHEREAS, the Provincial Government, through the PDRRMC Response Cluster lead agency, the PSWDO in partnership with the PDRRMO and other cluster member agencies, immediately conducted a Rapid Damage Assessment and Needs Analysis (RDANA) to the affected LGUs, to get the situation of the incidents and provide the response actions to these communities;

WHEREAS, the PDRRMC Response Cluster has recommended and conducted relief operations through distribution of food and non-food items to over 40,000 families directly or indirectly affected by the said incident to immediately provide basic needs to families and promote early recovery;

WHEREAS, as stated in the PDRRM Resolution No. 01, Series of 2023, the fund allocation for the whole year intended for the purchase of foodstuff for the conduct of relief operations during emergencies was already utilized for the payment of the withdrawn foodstuff, hence the need for an additional fund allocation as preparedness funds intended for an early response actions such as stockpiling and prepositioning;

WHEREAS, while this august body understands the need for additional funds, however, before considering the request for approval of the reversion of LDRRM Funds, this august body finds it necessary to be provided with the list of the 40,000 families directly or indirectly affected by the said incident, as the beneficiaries during the relief operations;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Andy A. Monday, Art Benjie C. Bulaong, Daud V. Linsag, Harold A. Montes, and Eleuterio C. Manaytay, it was




