A RESOLUTION RETURNING TO THE HONORABLE GOVERNOR NIÑO SOTERO L UY, JR., THROUGH THE PROVINCIAL DEVELOPMENT COUNCIL, THE HEREIN PDC EX-COM RESOLUTION NO. 19, SERIES OF 2023, WITHOUT ACTION, FOR THEIR REVIEW AND APPROPRIATE ACTION.

WHEREAS, submitted before this august body is the request of the Honorable Governor Niño Sotero L. Uy, Jr., for the passage of a resolution confirming the approval of the PDC-EXCOM Resolution No. 19, series of 2023, entitled: "A RESOLUTION RECOMMENDING THE CY 2023 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP)-2 IN THE TOTAL AMOUNT NINETY-NINE MILLION SEVEN HUNDRED EIGHTY-FIVE THOUSAND THREE HUNDRED FIFTY PESOS & 77/100 (P99,785,350.77), AS PROGRAMMED, AND ENDORSING THE SAME TO THE SANGGUNIANG PANLALAWIGAN (SP), THIS PROVINCE, FOR ITS APPROPRIATE ACTION";

WHEREAS, the said Resolution was approved by the Executive Committee on August 25, 2023;

WHEREAS, encompasses thereof, part of the sources of funds for the various priority Programs/Projects/Activities of the Provincial Government under the Supplemental AIP, is the Local Disaster Risk Reduction and Management Fund (LDRRMF) 2023 Current Appropriations, amounting to P18,608,000.00;

WHEREAS, specifically, the said amount of P18,608,000.00 is recommended to be reverted and be taken from the Procurement/Acquisition of disaster equipment for disaster response and rescue activities and reconstruction of public facilities, bldg. & other public infra. destroyed or damaged by calamity: a) Oplan Karsada – Rehab./Improv't and const. of roads damaged by flood and landslide – P5,000,000.00; b) Other Structures – Const. of Disaster Resilient transitional shelters – P3,608,000.00; and c) Other Structures – Const. of the State of the Art Standard Evacuation Center Phase I – P10,000,000.00;

WHEREAS, in conformity with the PDRRMC Resolution No. 01, series of 2023, the said amount of P18,608,000.00 is recommended to be made available to fund the Donations under the Maintenance and Other Operating Expenses of Disaster Prevention and Mitigation and Preparedness area of the PDRRM Office;

WHEREAS, while this august body understands the need for additional funds, however, before considering the request for approval of the reversion of LDRRM Funds, this august body find it necessary to be provided with the list of the 40,000 families directly or indirectly affected by the said incident, as the beneficiaries during the relief operations;

WHEREAS, corollary to the pending approval of the PDRRMC Resolution No. 1, series of 2023, the amount of P18,608,000.00 cannot be made as one of the sources of funds for the Supplemental Budget;

WHEREAS, Section 114(a) of RA 7160, provides among others that: "the policies, programs, and projects proposed by local development councils shall be submitted to the sanggunian concerned for appropriate action". However, this Sangguniang Panlalawigan believes that this august body is not precluded from raising questions and/or requiring the concerned agencies/offices with documents pertinent to the subject resolutions before its favorable consideration;

WHEREAS, it is recommended to return the request for approval of PDC-EXCOM Resolution No. 19, series of 2023, to the Local Chief Executive through the Provincial Development Council, in connection with the pending approval of the PDRRMC Resolution No. 1, series of 2023;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes, Andy A. Monday, Art Benjie C. Bulaong, Eleuterio C. Manaytay, and Daud V. Linsag, it was
