A RESOLUTION RETURNING TO THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., THROUGH THE LOCAL FINANCE COMMITTEE, THE HEREIN REQUEST FOR THE ENACTMENT OF SUPPLEMENTAL BUDGET NO. 2-2023, WITHOUT ACTION, WITH THE INFORMATION THAT THE SAME CANNOT BE ACTED BY THE 17<sup>TH</sup> SANGGUNIAN OF THIS PROVINCE PENDING SUBMISSION OF DOCUMENTS FROM CONCERNED IMPLEMENTING OFFICES/AGENCIES.

**WHEREAS,** submitted before this august body is the request of the Honorable Governor Niño Sotero L. Uy, Jr., dated August 25, 2023, for the passage of an appropriate resolution and Appropriation Ordinance for Supplemental Budget 2, for the funding of various Programs/ Projects/Activities to be taken from various fund sources, in the total amount of Ninety-Nine Million Seven Hundred Eighty-Five Thousand Three Hundred Fifty Pesos & 77/100 (P99,785,350.77), together with its corresponding Certifications, Statement of Appropriations and Funding Sources, duly signed by appropriate signatories;

WHEREAS, among the fund sources thereof is to be taken from the reversion of the Local Disaster Risk Reduction and Management Fund (LDRRMF) 2023 Current Appropriations amounting to P18,608,000.00, and the same amount is to be made available to fund the Donations under the Maintenance and Other Operating Expenses of Disaster Prevention and Mitigation and Preparedness area of the PDRRM Office;

WHEREAS, the said reversion and its subsequent appropriation to fund other PPAs is recommended by the PDRRM Council through its Resolution No. 1, series of 2023, dated March 28, 2023, subject for the approval of this Sangguniang Panlalawigan;

WHEREAS, while this august body understands the need for additional funds, however, before considering the request for approval of the reversion of LDRRM Funds, this august body finds it necessary to be provided with the list of the 40,000 families directly or indirectly affected by the said incident, as the beneficiaries during the relief operations;

**WHEREAS**, corollary to the pending approval of the PDRRMC Resolution No. 1, series of 2023, the amount of P18,608,000.00 cannot be made as one of the sources of funds for the Supplemental Budget. Consequently, PDC EX-COM Resolution No. 19, series of 2023, recommending the Supplemental AIP, containing the said amount, is deferred for approval;

WHEREAS, in view of the foregoing information, this Sangguniang Panlalawigan cannot pass and approve the requested legislative measures to authorize the enactment of the Supplemental Budget No. 2-2023 of the Province, prior to the confirmation and approval of the PDRMC Resolution No. 1, s. 2023, and PDC EX-COM Resolution No. 19, s. 2023, the same being pertinent to the budget;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Art Benjie C. Bulaong, Andy A. Monday, Eleuterio C. Manaytay, Harold A. Montes, and Daud V. Linsag, it was
