**WHEREAS**, Section 17(a) of Republic Act 7160, provides among others that: *“Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities xxx;*

**WHEREAS**, Municipal Ordinance No. 10, series of 2023, was forwarded by the Secretary to the Sangguniang Bayan of Tarragona, Mrs. Irene D. Tinong, on August 15, 2023, docketed as Communication No. 17-567-2023. The same was presented for consideration before the August Body for an appropriate legislative action;
