

A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE CITY GOVERNMENT OF MATI, REPRESENTED BY ITS CITY MAYOR, HONORABLE MICHELLE DENISE N. RABAT, RELATIVE TO DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER (DOPMC) AS REFERRAL FACILITY FOR THE CITY HEALTH OFFICE.

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the provincial government, shall "represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";

WHEREAS, presented for consideration before the August Body is the letter-request from the Honorable Governor Niño Sotero L. Uy, Jr., dated September 4, 2023, requesting for the passage of a resolution authorizing him for the aforementioned subject matter, docketed as Communication No. 17 – 593 - 2023;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Harold A. Montes, Shella Marie S. Go, Stephen Paul L. Uy, and Daud V. Linsag, it was
