UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF ANTIPAS, PROVINCE OF COTABATO, REPRESENTED BY ITS MUNICIPAL MAYOR, HON. 


