**RECONSTITUTION OF THE BIDS AND AWARDS COMMITTEE OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL**

The BAC Secretariat shall perform the functions and responsibilities stipulated in Section 14.1 of the Revised IRR (2016) of RA 9184 and issuances of the GPPB.

The BAC, TWG and BAC Secretariat shall give utmost priority to BAC assignments over all other duties and responsibilities until the requirements from the procurement at hand are completed, and shall perform jury duty whenever so required.

All pending procurement processes with the current BAC, TWG and BAC Secretariat are transferred to the newly reconstituted Bids and Awards Committee of the Provincial Government of Davao Oriental upon effectivity of this Order.

Qualified members of the BAC shall be entitled to a monthly honorarium not exceeding twenty five percent (25%) of their respective monthly salary, subject to availability of funds and existing rules and regulations.

All orders, memoranda, circulars or other issuances or parts thereof which are inconsistent with this Order are hereby deemed repealed and/or modified accordingly.

This Executive Order shall take effect on 15TH day of AUGUST, 2022 and shall be valid until revoked or amended.
