A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 570, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE FURTHER AMENDING ARTICLE X, SECTION 38, AND IN SECTION 3 OF ARTICLE XI OF CITY ORDINANCE NO. 314. SERIES OF 2018 AND REPEALING CITY ORDINANCE NO. 367, SERIES OF 2019", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, Section 16 of the Local Government Code of 1991, provides that: "Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx";

WHEREAS, submitted for review before the August Body is City Ordinance No. 570, series of 2023, transmitted by Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of the City of Mati, Davao Oriental, docketed as Communication No. 17-605, 2023, item No. 1;

**WHEREAS**, the said ordinance was enacted by the 7<sup>th</sup> Sangguniang Panlungsod of the City of Mati, this Province, on the 8<sup>th</sup> day of August 2023 to decongest the flow of vehicular traffic and to ensure the safety of motorists and pedestrians alike in the main city roads;

**WHEREFORE,** on motion of SP Member Daud V. Linsag, duly and jointly seconded by SP Members Rotchie M. Ravelo, Harold A. Montes, and Shella Marie S. Go, it was
