A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 570, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE FURTHER AMENDING ARTICLE X, SECTION 38, AND IN SECTION 3 OF ARTICLE XI OF CITY ORDINANCE NO. 314, SERIES OF 2018 AND REPEALING CITY ORDINANCE NO. 367, SERIES OF 2019”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(a)(1) OF REPUBLIC ACT 7160.


