A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 574, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING TWO COTERMINOUS POSITIONS, ONE (1) PRIVATE SECRETARY I – SG 11 AND ONE (1) SECURITY OFFICER I – SG 11 UNDER THE OFFICE OF THE CITY MAYOR, CITY OF MATI", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO SECTION 458(a)(1) OF RA 7160.

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that: "every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its services requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";

WHEREAS, Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, forwarded the above mentioned ordinance, thru his letter, dated September 7, 2023, and was received by the SPSSO on September 8, 2023, docketed as Communication No. 17-605-2023. The same was referred to the Committee on Labor, Employment, Civil Service, Human Resource Development;

WHEREAS, City Ordinance No. 574 was enacted to create the said positions stated therein which are deemed necessary in order to address the LGU's employment concerns;

WHEREFORE, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Daud V. Linsag, Shella Marie S. Go, Anna Cheryl N. Castro, and Andy A. Monday, it was
