**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-20-01 OF THE MUNICIPALITY OF MANAY, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 2023-20-01 of the Municipality of Manay, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of **THIRTY-FOUR MILLION ONE HUNDRED FIFTY THOUSAND FIVE HUNDRED EIGHTY-FIVE PESOS & 76/100. (P34,150,585.76)**, was submitted to this Sanggunian for review on June 22, 2023, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;



**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Eleuterio C. Manaytay, Daud V. Linsag, and Andy A. Monday, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2023-20-01 of the Municipality of Manay, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2023 Supplemental Annual Investment Program (SAIP)/Development Plan pursuant to Sections 287 and 305(i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2016, dated November 18, 2016, and DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017;
2. Lump sum appropriations in Other Special Purpose Appropriation / Other MOOE / Capital Outlay / Other General Services, etc. shall be subject to Sections 305(b) and 335 of RA 7160; RA 9184 (Government Procurement Reform Act) and its IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures.

**RESOLVED FURTHER**, to inform the Municipality of Manay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Manay, Davao Oriental, through the Municipal Mayor.


