A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 01-17-2023 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY.

WHEREAS, Appropriation Ordinance No. 01-17-2023 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of <u>TWELVE MILLION SEVEN HUNDRED EIGHTY-SEVEN THOUSAND NINE HUNDRED SEVEN PESOS & 72/100. (₱12,787,907.72)</u>, was submitted to this Sanggunian for review on July 03, 2023, pursuant to the provisions of Republic Act No. 7160;

MOREOVER, the LGU is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 112, dated June 10, 2016, which requires that "Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review";

**RESOLVED FURTHER,** to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.
