

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 02. SERIES OF 2023, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY.

**RESOLVED FURTHER,** to inform the Municipality of Governor Generoso, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental, through the Municipal Mayor.
