**WHEREAS**, Municipal Ordinance No. 11, series of 2023, entitled: "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 09, S. 2023 PARTICULARLY IN ITS ENACTING CLAUSE, SECTIONS 1, 3 AND 4 (FIRST SENTENCES), DATE OF ADOPTION AND CERTIFICATION BY CHANGING THE WORD "MUNICIPALITY" TO "SANGGUNIANG BAYAN"; IN SECTION 1, BY ADDING THE STATEMENTS "WHICH

SAMUEL L. UY AND THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) REPRESENTED BY ITS LENDING CENTER HEAD, AVP AMELITA B. PINANDAY, WITH THE LOAN AMOUNT OF ONE HUNDRED THIRTY MILLION PESOS (P 130,000,000.00) TO FINANCE THE FOLLOWING PROJECTS:

- A. CONSTRUCTION OF A TWO (2) STOREY BUILDING IN BARANGAY CENTRAL AS TOURISM FACILITY WITH AMENITIES- P 40,000,000.00
- B. IMPROVEMENT OF THE MUNICIPAL GYMNASIUM- P 10,000,000.00
- C. PROCUREMENT OF VARIOUS BRAND-NEW LOCALLY SOURCED HEAVY EQUIPMENT- P 80,000,000.00 "


