A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2023-13 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE ADOPTING AND LOCALIZING REPUBLIC ACT NO. 11313, “AN ACT DEFINING GENDER-BASED SEXUAL HARASSMENT IN STREETS, PUBLIC SPACES, ONLINE WORKPLACES, AND EDUCATIONAL OR TRAINING INSTITUTIONS, PROVIDING PROTECTIVE MEASURES AND PRESCRIBING PENALTIES THEREFOR”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, Municipal Ordinance No. 2023-13, otherwise known as the “Bawal Bastos Ordinance of Banaybanay” was enacted during the 54th regular session of the 16th Sangguniang Bayan of Banaybanay, on August 22, 2023;

WHEREAS, the said municipal ordinance was passed and approved in adherence to Section 9(a) of the Implementing Rules and Regulations (IRR) of Republic Act No. 11313 or known as the “Safe Spaces Act”;

WHEREAS, in his letter dated August 16, 2023, Mr. Eden Celestino S. Cacho, Secretary to the Sangguniang Bayan of Banaybanay, Davao Oriental, submitted the above municipal ordinance for legislative review of the Sangguniang Panlalawigan, docketed as Communication No. 17-632-2023;

WHEREFORE, on motion of SP Member Shella Marie S. Go, duly and jointly seconded by SP Members Harold A. Montes, Anna Cheryl N. Castro, and Rotchie M. Ravelo, it was


