A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 569, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING THE PROVISIONS ON CHAPTER 1, SECTION 5B – 4 OF THE CITY ORDINANCE NO. 3, SERIES OF 2007 OTHERWISE KNOWN AS “AN ORDINANCE ESTABLISHING THE MARKET CODE OF THE CITY OF MATI” TO CONVERT STALL NO. 30 FROM RICE AND CORN SECTION TO BEAUTY PARLOR/BARBERSHOP SECTION”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.




