A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 561, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE SETTING GUIDELINES ON THE OPERATION AND MANAGEMENT OF CITY OF MATI FISHPORT, PROVIDING FEES, PENALTY THEREOF, AND FOR OTHER PURPOSES", SUBJECT EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

**WHEREAS,** Section 16 of the Local Government Code of 1991, provides that: "Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incident for its efficient and effective governance and those which are essential to the promotion of the general welfare xxx;

WHEREAS, submitted for review before the August Body is City Ordinance No. 561, series of 2023, forwarded by Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of Mati, this province, thru his letter, dated September 18, 2023, docketed as Communication No. 17-626-2023:

WHEREAS, the aforementioned ordinance was enacted by the 7<sup>th</sup> Sangguniang Panlungsod of Mati, this province on the 29<sup>th</sup> day of August 2023, purposely to promote the proper operation of fish port and management including preservation, development and utilization of Municipal Waters, fisheries and marine resources, to achieve food security and environmental balance as well;

**WHEREFORE,** on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Harold A. Montes and Daud V. Linsag, it was
