AN ORDINANCE APPROVING THE ABOLITION OF ONE (1) ADMINISTRATIVE OFFICER II (SG 11) (ITEM NO. 61), ONE (1) ADMINISTRATIVE ASSISTANT III (SG-9) (ITEM NO. 52), AND CREATION OF TWO (2) ADMINISTRATIVE ASSISTANT IV (BOOKBINDER IV) (SG 10) POSITIONS IN THE PLANTILLA OF PERSONNEL OF THE SANGGUNIANG PANLALAWIGAN SUPPORT SERVICES OFFICE.

WHEREAS, the Sangguniang Panlalawigan Support Services Office (SPSSO) has requested the Sangguniang Panlalawigan, through the Honorable Vice Governor Nelson R. Dayanghirang, Jr., Presiding Officer, to pass an Ordinance abolishing and creating of positions under the said office;

WHEREAS, the said actions are deemed necessary to ensure that all positions remain relevant, functional and properly attuned to the present dynamics for the effectiveness and efficiency of public service delivery;

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that: *“Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its services requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission”*;

WHEREFORE, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Daud V. Linsag, Rotchie M. Ravelo, Anna Cheryl N. Castro, and Shella Marie S. Go, it was

Be it ordained by the 17th Sangguniang Panlalawigan of Davao Oriental, in session duly assembled that:

SECTION 1. Abolition of positions – the following positions are hereby approved for abolition, to wit:

- One (1) ADMINISTRATIVE OFFICER II (Item No. 61) (SG – 11)
- One (1) ADMINISTRATIVE ASSISTANT III (Item No. 52) (SG – 9)

Funding of the said positions shall be reverted to Unappropriated Balances of the CY 2024 General Fund of the Province.

SECTION 2. Creation of positions – two (2) positions ADMINISTRATIVE ASSISTANT IV (Bookbinder IV) (SG – 10) are hereby approved for creation. Funding for the newly created positions shall be included in the CY 2024 General Fund of the Province.

SECTION 3. Implementation – the implementation and execution of this Ordinance shall be subject to the existing and applicable Civil Service Laws, Rules and Regulations and shall be in accordance with relevant budget circulars of the Department of Budget and Management and other pertinent laws thereof.

SECTION 4. REPEALING CLAUSE – all existing measures with a provision or provisions which are inconsistent with this ordinance, the same are hereby amended or repealed accordingly.

SECTION 5. SEPARABILITY CLAUSE - Should any provision of this Ordinance is found invalid and declared unconstitutional, the rest of the provisions not otherwise affected shall remain effective and enforceable.

SECTION 6. EFFECTIVITY - this Ordinance shall take effect immediately upon approval hereof.


