AN ORDINANCE REVERTING TO THE UNAPPROPRIATED BALANCES OF THE CY 2023 GENERAL FUND THE APPROPRIATIONS FOR SAVINGS FROM SALARIES AND OTHER COMPENSATIONS, **MONETIZATION** MISCELLANEOUS AND PERSONAL BENEFIT FUND (TERMINAL LEAVE) OF VARIOUS OFFICES, CAPITAL OUTLAY OF VARIOUS OFFICES, 20% LOCAL GOVERNMENT DEVELOPMENT FUNDS (LGDF) - FY 2021 & 2022 CONTINUING APPROPRIATIONS, AND TRUST FUND UNDER THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (UNEXPENDED LDDRMF FOR FY 2022); AND FURTHER AUTHORIZING ITS CORRESPONDING APPROPRIATIONS TO FUND VARIOUS PRIORITY PROGRAMS /PROJECTS/ ACTIVITIES OF THIS PROVINCE.

REVERSION - It is hereby approved the reversions to the CY 2023 Unappropriated Balances of the General Fund Annual Budget of the Provincial Government of Davao Oriental the appropriations for the savings from salaries and other compensations of various offices, monetization and miscellaneous and personal benefit fund (terminal leave) of various offices, capital outlay of various offices, 20% local government development funds (LGDF) - FY 2021 & 2022 continuing appropriations, and trust fund under the Provincial Disaster Risk Reduction And Management Office (Unexpended LDDRMF for FY 2022), in the amount of **₱75,872,634.69**, to wit:
