**A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE NATIONAL HOUSING AUTHORITY (NHA), REPRESENTED BY ITS REGIONAL MANAGER, ENGR. CLEMENTE A. DAYOT, FOR THE CREATION OF THE PROJECT INTER-AGENCY COMMITTEE (PIAC) IN MATI CITY, DAVAO ORIENTAL.**

**WHEREAS**, presented for consideration of this August Body is a letter of the Honorable Governor Niño Sotero L. Uy Jr., dated September 12, 2023, requesting for an authority, for and in behalf of the Provincial Government of Davao Oriental, to enter into a Memorandum of Understanding with the National Housing Authority;

**WHEREAS**, NHA XI Regional Office plans to develop NHA-owned properties for its housing program specifically at the 11.9 and 4.4 hectares of land situated in Barangay Dahican, Mati City, Davao Oriental. The said parcel of land are presently

occupied by more than 475 Informal Settler Families (ISFs) hindering the agency's implementation of its program due to illegal occupancy of the said ISFs;

**WHEREAS**, to ensure a lawful, peaceful and humane eviction/dismantling of structures pursuant to Section 4 of NHA MC No. 2506, the NHA requires the organization of a Project Inter-Agency Committee (PIAC) to be composed of duly authorized representatives from concerned government agencies, CSOs, NGOs, Office of the Provincial Governor, and other stakeholders, through a Memorandum of Understanding. Hence, this authorization.

**WHEREFORE**, on motion of SP Member Anna Cheryl N. Castro, duly and jointly seconded by SP Members Daud V. Linsag, Shella Marie S. Go, Harold A. Montes, Eleuterio C. Manaytay, Andy A. Monday, and Rotchie M. Ravelo, it was


